## GENERAL RULES OF DISCIPLINE AND NORMS OF THE INSTITUTION

2. Along with the duly filled prescribed application form, the student needs to submit copies of marks statements, caste/category certificate, Transfer certificate and other documents. Originals to be produced at the time of admission. Students from outside Karnataka should also produce migration / eligibility certificate. Three stamp size photographs should be provided at the time of admission.
3. Student seeking admission should bring their parents to the college at the time of admission. They have to give an undertaking in the prescribed Declaration form. Fees once paid shall not be refunded under any circumstances.
4. All the students are required to be punctual and regular to their classes. Leave of absence must be obtained from the college when absent from the college due to unforeseen difficulties. A minimum of 85% attendance in each subject is essential to qualify for the final examination.
5. Students should abide by all the rules and regulations stipulated by the college from time to time.
6. The students are advised not to indulge in damaging the college property. In the event of any such damages, the students are to bear the cost of the damaged property.
7. The students are not allowed to go on excursion/picnic without the permission from the Principal.
8. Students who are found guilty in misconduct, malpractice and whose presence is found to be detrimental to the order and discipline of the college, are liable to be expelled from the college without any notice.
9. The decision of the college in all matters of curricular or extra curricular activities is final and binding on the students.
10. Parents, guardians are requested to contact the concerned department Heads/Principal, periodically to know about the conduct, progress and attendance of their wards.
11. In case of loss of identity card / library card, students are advised to report to the college.
12. Parents, guardians will please note that those who are admitted to the college are expected to maintain a high standard of diligence and good conduct and to abide by the rules of the college.
