1. **NAME OF THE ASSOCIATION :** Lingraj Appa Engineering College Alumni Association,




3. **AREA OF OPERATION:**


4. **AIMS & OBJECTS. :**


1. To promote mutually beneficial interaction between the Alumni and the present students of the association and between the Alumni themselves.


**RULES AND REGULATION**


**1. EXPLANATION**

- a) Association Means : Any aims and objects (mentioned in the Memorandum of Society) established. Run, maintained protect etc; by the Association.
- b) General Body Means : The General Body comprising of all the valid members of all categories under the rules and regulations of the Association.
- c) Board of Management :- The Board of Management constituted by the General Body of the Society and see all the work of the Association.
- d) Members Means :- A person who attain the age of 21 years and above and Full fill all the conditions of the Association and enrolled as a members of the Association and enrolled as a members of the Association

**1. MEMBERSHIP :-**

- 1) Membership of the Society shall be opened to the person's age above 21 years & who subscribes to the aims & object of the Society to abide these rules thereof.
- 2) Every member should strictly abide by the constitution, rules and regulations of the Society.
- 3) Every member has the right to participate in all the activities of the Society in accordance with the constitution.
- 4) Every member having sound mind of the age of 21 years and above and declared for an offence of moral tripartite.
- 5) Members who has once contributes Rs.100/- as membership fee at the time of first registration in the Society & after declared as member of the Society he/she has to pay yearly contribution of Rs.100/-
- 6) Members who have once contributed the membership fee/donation are not refundable under any circumstances & also not entitled to transfer in the name on any other person / member. However the management committee of the Society reserves the right either to accept or reject anybody's members.

- 7) The admission to the membership can be done on an application along with the prescribed fees of Rs.100/- and recommended by any two members of the management committee of the Society & accepted by the management committee of the Society by 2/3<sup>rd</sup> majority. It shall be within the power of the management committee of the Society to accept or reject any membership without assigning reasons by 2/3<sup>rd</sup> majority.
- 8) The members shall be ceased or cancelled in case of death or involved in any crime or bad character if illegal or anti social activities or failed to pay membership fees or absent continuously in 3 meetings by 2/3<sup>rd</sup> majority in the meeting.
- 9) A member can retire voluntarily from the membership by giving a written resignation to the secretary.


3. **CONSTITUTION OF THE GENERAL BODY:**


- a) The general body of Association shall consist of all members.
- b) The general body shall meet once a year or in the middle if necessary for transacting the following items.
- c) To consider and adopt the report of the activities of the Association during the past year / coming year and the audited accounts balance sheet relating to the year under report.
- d) To elect the office bearer of the managing committee
- e) To review the progress and to adopt resolution thereon amendment of rule and regulations
- f) It is the policymaking body of Society and given approval & ratification for the projects. Annual plans & reports. Budgets & expenditures of the Association.
- g) The general body of the Association reserves the right to constitute from Governing council, Project Management committee & other committee as required to discharge, the objectives of the Society.
- h) Only the General body has powers to dissolve the Society and bring in any amendments. In Bye-law of the Society with the approval of 3/4 majority.

4. **CONSTITUTION OF THE BOARD OF MANAGEMENT :**

The management of all matters connected with the Association shall be managing committee. The managing committee shall consist of the President, Vice President, Secretary, Treasurer & Governing body members total 13.

- a) The managing Committee of Association shall have all the powers to implement the aim and objects of the Society, including momentary transactions and administration.
- b) The term of office the managing Committee of Association shall be 3 years.

5. MEETING

1. The General Body shall meet three a year of middle if necessary as per requirement.
2. The managing committee of Association shall meet at least once in a three months or middle in necessary as per requirement.
3. At least 07 days notice together with the agenda shall be given for meeting.
4. The quorum for a meeting shall be 2/3 majority compulsory.
5. Accidental omission of to give notice of a meeting or non - receipt of a meeting by any person entitled to receive notice shall not invalidate the proceeding of that meeting.
6. The president shall chair the Annual General meeting. In his / her absence vice president or a chairperson should be elected from the members present in the meeting. (in the absence of vice president )

6. OFFICE BEARERS AND THEIR POWERS:

The office bearers shall be elected yearly at the annual meeting of the Association by a majority of vote of the managing committee.

a) PRESIDENT :


1. The President of the Association shall Preside over all the meetings of the Association.
2. The President has the responsibility to represent the Association in any meeting other than Association own meeting if for any reason he can represent, the president shall.
3. If the President ship becomes vacant / absent in the meeting/in the middle of the year the vice-President shall act as President of the time being or un till new election of the President in the work of the Association to assist to the president.
4. All the properties (both movable & immovable), agreements & other document of the Association shall be in the name of both President & Secretary.


b) POWERS OF THE VICE-PRESIDENT:

The Vice-President of the association shall dishrag all such assignments as entreated to him by the board of management from time to time and to officiate as president in the absence of president.

c) SECRETARY:-

1. It shall be duty of the Secretary of the Society to call all the meetings, to issue circulars, to correspond, to all appointments to see all the administrations of aims and objects of the Society and in Society etc; under the directions of the Board of Management and to carry out their instructions.
2. To arrange for the election of the Society and to prepare the agenda and to convince the meetings.

d) **JOINT SECRETARY:**

The Joint Secretary of the Association shall assist the Secretary in the discharge of his duties and responsibilities. Whenever the Secretary is on tour or otherwise absent from the Association the Joint Secretary shall perform all the duties of the Secretary.

e) **TREASURER:-**

The Treasurer shall be responsible for the issue of receipts and vouchers for funds received or paid but by the Society and for the preparation of annual budget estimates/accounts. He shall be incharge of all collected funds of the Society.

7. **FINANCIAL ASSISTANCE :-**

The financial resources for the objects and the activities of the Society shall through:-

- a) Donation from members, public etc.
- b) Loan and Grants from Members, Govt. Banks and any other authorities.
- c) Cultural activities/programmes etc.

All the property and funds of the Society shall belong to the Society collectively. No Individual members shall have any property and funds right over them.

8. **BANK ACCOUNTS:-**

All Bank accounts in the name of the Society shall be operated through cheque, draft etc. With the Joint Signature of the President & Secretary of the Society.

9. **AUDIT :-**

The Accounts of the Society shall be audited by a Auditor in every year and the audit report should be approved by the General Body. All the audit rectification shall brought to the notice of the Members with 15 days after attending the audit rectification.

10. **ANNUAL RETURNS :-**


Annual returns and list of the Board of Management members with their particulars be filed in every year with the Registrar of Societies, Bidar in accordance with section-13 of the KSR Act.1960.


11. **ELECTION OF THE ASSOCIATION**

- a) The vote would be casted on secret Ballot method.
- b) The election of the Office bearers will be held in supervision of nominated person/persons nominated by the Board of Management and Advisors of the Society.

12. **AMENDMNET:-**

- a) 2/3<sup>rd</sup> majority of the General Body can amend the constitution of the Society in meeting.
- b) The amendment of the Society shall be made in accordance with section-9 and 10 of the KSR Act.1960. Such amendments should be approved by the registrar of societies, Bidar before affecting it.

13. DISSOLUTION OF THE ASSOCIATION :-

14. YEAR OF THE ASSOCIATION :-

The year of the Association is 1<sup>st</sup> April to 31<sup>st</sup> march.

15) AMALGAMATION :-


Regarding amalgamation and reorganization of the Club section 21, 22 and 23 of the Karnataka Societies Registration of the Act.1960 shall be followed.


16) FUNDS INVESTMENTS :-
