The following matters were discussed and decisions were taken:

1. Constitution and Responsibilities

The Committee reviewed its constitution and the responsibilities of its members for the Academic Year 2022-2023. Members were advised to remain vigilant and discharge their assigned responsibilities effectively.

2. Regulatory Compliance

The Committee reviewed the applicable provisions relating to the prevention and prohibition of ragging. It was reiterated that ragging in any form is strictly prohibited and that the Institution follows a **zero-tolerance policy**.

3. Awareness and Sensitization

The Committee decided to conduct Anti-Ragging awareness and sensitization programmes, particularly for newly admitted students. Students shall be informed about the prohibition of ragging, consequences of misconduct and available reporting mechanisms.

8. Counselling and Mentoring

The Committee emphasized regular interaction between faculty mentors and students. Students shall be encouraged to report any concern without fear.

9. Complaint Status

The Anti-Ragging complaint register and available reports were reviewed.

The Committee unanimously recorded that no complaint or incident of ragging has been reported at Lingaraj Appa Engineering College, Gornalli, as on the date of the meeting.
