MINUTES OF THE MEETING

Date: 11.08.2023

Proceedings

The Meeting of the Anti-Ragging Committee was held on 11.08.2023 under the chairmanship of the Principal.

The Chairperson welcomed all the members and emphasized the Institution's commitment to maintaining a **safe, inclusive, respectful and completely ragging-free environment** for all students.

The following matters were discussed and decisions were taken:

1. Confirmation of Previous Minutes: The minutes of the previous meeting were reviewed and confirmed.

The Committee reviewed its constitution and the responsibilities of its members for the Academic Year 2023-2024. Members were advised to remain vigilant and discharge their assigned responsibilities effectively.

2. Action Taken Report: The Committee reviewed the Action Taken Report and noted implementation of earlier preventive measures.

The Committee reviewed the applicable provisions relating to the prevention and prohibition of ragging. It was reiterated that ragging in any form is strictly prohibited and that the Institution follows a **zero-tolerance policy**.

3. Awareness and Sensitization: Awareness and orientation programmes were reviewed and regular sensitization was recommended.

The Committee decided to conduct Anti-Ragging awareness and sensitization programmes, particularly for newly admitted students. Students shall be informed about the prohibition of ragging, consequences of misconduct and available reporting mechanisms.

4. Student Counselling and Mentoring: Counselling activities were reviewed and regular faculty-student interaction was emphasized.

The Committee discussed the collection and proper maintenance of Anti-Ragging undertakings/declarations from students and parents, wherever applicable. The concerned staffs were instructed to maintain the records systematically.

5. Anti-Ragging Squad and Monitoring: The Squad's functioning was reviewed and regular and surprise inspections were advised.

The Committee reviewed the role of the Anti-Ragging Squad and decided to undertake regular and surprise inspections of vulnerable areas.

6. Vulnerable Areas: Continued vigilance was emphasized in classrooms, corridors, canteen, hostel premises, transport areas and other gathering points.

The Committee identified the need for continued vigilance in classrooms, corridors, canteen, hostel premises, transport areas and other student gathering points, wherever applicable.

7. Display and Communication: Notices, posters, helpline information and reporting mechanisms were reviewed and regular dissemination was continued.

The Committee emphasized regular interaction between faculty mentors and students. Students shall be encouraged to report any concern without fear.

8. Complaint Status: The complaint register and available reports were reviewed. **No complaint or incident of ragging was reported as on the date of the meeting.**

The Anti-Ragging complaint register and available reports were reviewed.

The Committee unanimously recorded that no complaint or incident of ragging has been reported at Lingaraj Appa Engineering College, Gornalli, as on the date of the meeting.

9. Effectiveness of Measures: Preventive measures were found satisfactory and their continuation with suitable improvements was recommended.

The Committee resolved to:

- Conduct regular Anti-Ragging awareness programmes.
- Maintain continuous vigilance in vulnerable areas.
- Conduct periodic/surprise inspections.
- Strengthen student counselling and mentoring.
- Ensure easy access to reporting mechanisms.
- Take prompt action if any complaint or information regarding ragging is received.

11. Final Resolution: The Committee resolved to continue the zero-tolerance policy and all necessary preventive measures.

After detailed deliberation, the Committee unanimously resolved to **continue the zero-tolerance policy towards ragging** and implement all necessary preventive measures throughout the academic year.

There being no other matter for discussion, the meeting concluded with a vote of thanks to the Chairperson.

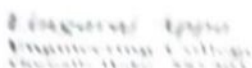
