Proceedings

The following matters were discussed and decisions were taken:

1. Constitution and Responsibilities

The Committee reviewed its constitution and the responsibilities of its members for the Academic Year 2025-2026. Members were advised to remain vigilant and discharge their assigned responsibilities effectively.

2. Regulatory Compliance

The Committee reviewed the applicable provisions relating to the prevention and prohibition of sexual harassment. It was reiterated that sexual harassment in any form is strictly prohibited and that the Institution follows a **zero-tolerance policy**.

3. Awareness and Sensitization

The Committee decided to conduct Anti-Sexual Harassment awareness and sensitization programmes, particularly for newly admitted students. Students shall be informed about the prohibition of sexual harassment, consequences of misconduct and available reporting mechanisms.

4. Anti-Sexual Harassment Undertakings

The Committee discussed the collection and proper maintenance of Anti-Sexual Harassment undertakings/declarations from students and parents, wherever applicable. The concerned staffs were instructed to maintain the records systematically.

5. College Internal Complaint Committee and Monitoring

The Committee reviewed the role of the College Internal Complaint Committee and decided to undertake regular and surprise inspections of vulnerable areas.

6. Vulnerable Areas

The Committee identified the need for continued vigilance in classrooms, corridors, canteen, hostel premises, transport areas and other student gathering points, wherever applicable.
